

Terms of Use

These terms of use govern your access to and use of the entire contents of the website available at www.gobu.ai ("Website") (including our software-as-a-service platform known as 'Gobu' (the "Tool"), owned and operated by Gobu Labs AB, a company registered with Bolagsverket under the number 559258-1614 which operates from Sankt Eriksgatan 63A 11234, Stockholm, Sweden ("Gobu ", "us", "we", "our"). Please read these terms of use carefully before using the Website and the Tool. They are a legal agreement between you and Gobu. Using any part of the Website and the Tool indicates that you accept these terms of use. If you do not accept these terms of use, please do not use the Website or the Tool, cease downloading the Website, or leave the Website. Gobu remains the owner of the Website and the Tool at all times. Gobu may revise these terms of use at any time by updating this posting. You should check the Website from time to time to review the current terms of use because the up-to-date terms of use are the ones that will be binding on you.

1. The Tool

1.1 Gobu offers and maintains the Tool to provide one or more of the following services to you:

- (a) AI assistant to aid in research and analyzing articles
- (b) a text editor that allows multimedia file upload;
- (c) a collaborative digital whiteboard;
- (d) an archive that stores all files, docs (documents) and whiteboards; and
- (e) a variety of methods for exporting and sharing the contents of documents
- (f) Microsoft Word add-in to ask questions to articles and cite them using AI.

1.2 Some of the above-mentioned services are free. Some are paid. They vary in duration. If you receive services for free, we reserve the right to cap your use at our sole discretion.

2. Fees and Payment

2.1 You shall pay the applicable fee to us as set out in the price list, which can be found [here](#).

2.2 All sums payable under these terms of use are inclusive of VAT, if applicable.

2.3 Refunds on all paid plans are only given within the first 3 days after the purchase date. Refunds are provided only one time and only for the first-time subscribers.

2.4 You may cancel your Subscription at any time, but please note that such cancellation will only be effective at the end of the then-current Subscription period. Unless required by law, you will not receive a refund of any portion of the subscription fee paid for the then-current subscription period at the time of cancellation.

2.5 You may downgrade your Subscription at any time, but please note that such downgrade will only be effective at the end of the then-current Subscription period. Unless required by law, you will not receive a refund of any portion of the subscription fee paid for the then-current subscription period at the time of downgrade.

2.6 You may upgrade your Subscription at any time by paying the difference between your plan and the plan you want to upgrade to.

2.7 Auto-Renewal: You agree that at the end of each Billing Cycle, your Subscription will automatically renew and your payment method for such Subscription will automatically be charged at the start of each new Subscription period for the fees and taxes applicable to that Billing Cycle, under the same conditions as the prior Billing Cycle unless you cancel your Subscription prior to your renewal date.

A valid payment method, including credit card, is required to process the payment for your Subscription. You must provide Gobu with accurate and complete billing information including full name, address, state, zip code, and valid payment method information. By submitting such payment information, you automatically authorize Gobu to charge all Subscription Fees incurred through your account to any such payment instruments. Should automatic billing fail to occur for any reason, Gobu may attempt to charge the credit card on file one or more times. Should payment continue to fail, the Subscription will be, at Gobu's sole discretion, canceled or downgraded and you may lose access to certain paid features and/or your Gobu account. You may cancel the renewal of your Subscription either through your online profile management page or by contacting Gobu customer support team at hello@gobu.ai and indicating your intention to cancel your Subscription.

2.8 Fees and Fee Changes: Gobu, in its sole discretion and at any time, may modify the Subscription Fees for the Subscriptions. Any Subscription Fee change will become effective at the end of the then-current Billing Cycle. Gobu will provide you with reasonable prior notice of any change in Subscription Fees. Your continued use of the Service constitutes your agreement to pay the modified Subscription Fees. Subscription Fees are stated may be inclusive or exclusive of any taxes or similar governmental assessments of any nature, including, for example, value-added, sales, use or withholding taxes, assessable by any jurisdiction (collectively, "Taxes"). If the Subscription Fees are exclusive of the the taxes, you will

be responsible for paying all Taxes associated with your Subscription, except for those taxes based on our net income. Should any payment for the Service be subject to withholding tax by any government, you will reimburse us for such withholding tax.

2.9 Apart from the refund policy detailed for all the Plans, sales are final and non-refundable.

2.10 If you have used a trial period and subsequently purchased a subscription, you are not eligible for a refund of the subscription fee. By proceeding with the subscription purchase, you agree that the trial period provided sufficient opportunity to evaluate the service and its features. Unfortunately, refund requests for subscriptions following a trial period won't be accommodated under any circumstances.

However, you may cancel your subscription at any time before the trial period ends to avoid being charged for the next billing cycle. Cancellations can be made directly from your account profile. Please note that your access to the subscription service will remain active until the end of the trial period.

3. Promotions and Marketing Offers

3.1 Gobu may offer promotional offers from time to time, which may include promo codes or account credits, may be subject to expiration dates and may only be applicable to selected users of the Tool. Promo codes are only applicable to the first subscription cycle and will not be applied to the next subscription cycles unless otherwise stated in the promotion. Gobu reserves the right to remove credit from a user account or end a promotion without notice if, at the sole discretion of Gobu, it believes a user is not acting in good faith in relation to the terms of the promotion.

4. Use of the Website, the Add-in and the Tool

4.1 During the term of the agreement the user gets access to and the right to use the Tool in accordance with these terms of use and Gobu's Privacy Policy.

4.2 All images, text, icons and other content on the Website, the Add-in and the Tool ("Content"), as well as the arrangement of the Content on the Website and the Tool, is protected by copyright and other intellectual property rights. Except as provided in these terms of use, or otherwise in writing by Gobu, you are not given any right to use the Website, the Tool or the Content or its arrangement. Nothing in these terms of use gives you a right to use any of Gobu trademarks or the trademarks of any third parties on the Website or the Tool.

4.3 Unless you have entered into a separate written agreement with us, you shall not copy, republish, frame, link to, download, transmit, modify, adapt, rent, lease, loan, sell, assign, distribute, license or sublicense the Website, the Tool or any of the Content. No copyright and/or other intellectual property notices or watermarks on any Content shall be deleted or modified.

4.4 You shall not disassemble, decompile, reverse-engineer or create derivative works based on the whole or any part of the Website and the Tool except to the extent allowed by law.

5. Your access to our Website, the Add-in and the Tool

5.1 While Gobu endeavors to ensure that the Website, the Add-in, and the Tool are normally available 24 hours a day, Gobu shall not be liable if for any reason the Website and the Tool are unavailable at any time or for any period.

5.2 Access to the Website, the Add-in, and the Tool may be suspended temporarily and without notice in the case of system failure, maintenance or repair or for reasons beyond Gobu's control.

5.3 To access the Tool you must have an account associated with a valid e-mail address and after the free trial process a valid form of payment method. When you register an account with us and choose a password to protect your secure account, you are responsible for maintaining the confidentiality of your password. If you become aware of any unauthorized use of your account, you must notify us and you should change your password immediately. You are solely responsible for all activities that occur under your password and/or account. You shall not permit anyone else to use your account.

5.4 Subscription to Gobu means the subscribers can access the tool as long as the service is available to the public. However, the company does not take any responsibility or bear any liability to the users for any event that hinders the service availability. For avoidance of doubt, in the case that the company stops its activities or removes the tool from public access, the company will not bear any liability, and will not make any payments or refunds to the subscribers.

6. Your Privacy

6.1 Gobu is committed to respecting your privacy and the privacy of all individuals using the Website and the Tool. More information regarding how Gobu uses your personal data can be found in Gobu's Privacy Policy.

7. Your Content and confidentiality

7.1 Audio/visual/text content submitted to Gobu by you (and any intellectual property rights in it) ("Your Content") is owned by you or your licensor. The Tool is

used by you so that we can produce your documents. Those documents (and any intellectual property rights in them) are owned by you, subject to you having paid the fees required under these terms of use.

7.2 Gobu shall have no obligations with respect to Your Content other than to perform the services as set out under these terms of use. You are solely responsible for such material.

7.3 You are prohibited from posting or transmitting to or from the Tool any material:

- (a) that is threatening, defamatory, obscene, indecent, seditious, offensive, pornographic, abusive, liable to incite racial hatred, discriminatory, menacing, scandalous, inflammatory, blasphemous, in breach of confidence, in breach of privacy or which may cause annoyance or inconvenience; or
- (b) for which you have not obtained all necessary licenses and/or approvals; or
- (c) which constitutes or encourages conduct that would be considered a criminal offence, give rise to civil liability, or otherwise be contrary to the law of or infringe the rights of any third party, in any country in the world;
- (d) which is technically harmful (including, without limitation, computer viruses, logic bombs, Trojan horses, worms, harmful components, corrupted data or other malicious software or harmful data);
- (e) contains or discloses another person's personal information without his or her written consent; or
- (f) collects or solicits another person's personal information for commercial or unlawful purposes.

7.4 You shall not:

- (a) use the Website/Add-in and/or the Tool the Content, or the services in any unlawful manner;
- (b) misuse the Website/Add-in and/or the Tool (including, without limitation, by hacking or inserting malicious code);
- (c) resell the Website/Add-in and/or the Tool, the Content or the services;
- (d) infringe our or any third party's intellectual property rights in your use of the Website, the Tool, the Add-in, the Content, or the services;
- (e) use the Website/Add-in and/or the Tool to transmit chain letters, junk or spam;
- (f) collect or solicit another person's personal information for commercial or unlawful purposes.
- (g) frame or use any framing techniques to enclose the Website /Add-in and/or the Tool or any part of them;
- (h) take any action that in our sole discretion places an unreasonable or disproportionately large load on our servers or other infrastructure; or

(i) use the Website /Add-in and/or the Tool in any way which may cause, or be likely to cause, access to or use of the Website, the Tool or the services to be interrupted, damaged or impaired in any way.

8. Links to and from other websites and apps

8.1 Links to third-party Websites and apps on the Website, Add-in and the Tool are provided solely for your convenience. Gobu has not reviewed all of these third-party websites and apps and does not control and is not responsible for these websites/apps or their content or availability. Gobu does not endorse or make any representations about them, or any material found there, or any results that may be obtained from using them. If you decide to access any of the third-party websites/apps linked to the Website, you do so entirely at your own risk.

9. Disclaimer

9.1 While Gobu endeavors to ensure that the Content is correct, Gobu does not warrant the accuracy and completeness of the Content. Gobu may make changes to the Content at any time without notice. The Content may be out of date, and Gobu makes no commitment to update such material.

9.2 The Website, the Add-in and the Tool are provided “as is”, without any conditions, warranties or other terms of any kind, other than those provided in these terms. 10. Indemnity

10.1 You shall indemnify Gobu Labs AB against any loss, damages, costs or expenses which are awarded against or incurred by Gobu Labs AB as a result of any claim or threatened claim (including any claim or threatened claim by a third party) arising out of or related to:

- (a) any breach by you of any of these terms of use or applicable law;
- (b) your misuse of the Website, the Add-in and/or the Tool;
- (c) any content you post on or transmit via the Website, Add-in and/or the Tool; and/or
- (d) your infringement of intellectual property rights.

11. Liability

11.1 Nothing in these terms of use shall exclude or limit either your or Gobu Labs AB's liability for:

- (a) death or personal injury resulting from the negligence of the other or their servants, agents or employees;
- (b) fraud or fraudulent misrepresentation; or
- (c) breach of any implied condition as to title or quiet enjoyment.

11.2 Subject to clause 11.1, nothing in these terms of use shall exclude or limit your liability under clause 11 (Indemnity).

11.3 Subject to clauses 11.1 and 11.2, neither you nor Gobu shall be liable in contract, tort (including, without limitation, negligence), pre-contract or other representations (other than fraudulent misrepresentation) or otherwise arising out of or in connection with these terms of use for:

- (a) any economic losses (including, without limitation, loss of revenues, profits, contracts, data, business, anticipated savings or cost of substitute services);
- (b) any loss of goodwill or reputation; or
- (c) any special, indirect or consequential losses,

in any case, whether or not such losses were within the contemplation of you and Gobu at the date of these terms of use, suffered or incurred by you or Gobu arising out of or in connection with the provisions of, or any matter under, these terms of use.

12. Termination

12.1 Gobu Labs AB may terminate these terms of use immediately by written notice to you:

- (a) if you commit a material or persistent breach of these terms of use which you fail to remedy (if remediable) within 14 days after the service of written notice requiring you to do so; and/or
- (b) if you breach any of clause 4.

12.2 You may discontinue your use of the Website, Add-in, and/or the Tool at any time. These terms of use will continue to apply to past use of the Website and/or the Tool by you.

12.3 On termination for any reason:

- (a) all rights granted to you under these terms of use shall cease;
- (b) content transmitted by you via the Website, Add-in, and/or the Tool may or may not (at our discretion) remain on our servers (or servers controlled by us); and
- (c) you must immediately cease all activities authorized by these terms of use.

12.4 On your discontinuance of use of the Website, Add-in, and the Tool and your account remaining dormant for longer than 90 days we may delete the contents of your account and your documents will be lost forever. We will try to notify you before we do this, but we are not obliged to do so. We recommend that you regularly save and/or export your documents.

13. Miscellaneous

13.2 We will not be liable or responsible for any failure to perform, or delay in performance of, any of our obligations under these terms of use that is caused by any act or event beyond our reasonable control, including failure of public or private telecommunications networks ("Event Outside Our Control"). If an Event Outside Our Control takes place that affects the performance of our obligations under these terms of use:

(a) our obligations under these terms of use shall be suspended for the duration of the Event Outside Our Control; and

(b) we will use our reasonable endeavors to find a solution by which our obligations under these terms of use may be performed despite the Event Outside Our Control.

13.3 We may transfer our rights and obligations under these terms of use to another organization, but this will not affect your rights or our obligations under these terms of use.

13.4 You may only transfer your rights or obligations under these terms of use to another person if we agree in writing.

13.5 A person who is not a party to these terms of use has no right to enforce any term of these terms of use.

13.6 If we fail to insist that you perform any of your obligations under these terms of use, or if we do not enforce our rights against you, or if we delay in doing so, that will not mean that we have waived our rights against you and will not mean that you do not have to comply with those obligations. If we do waive a default by you, we will only do so in writing, and that will not mean that we will automatically waive any later default by you.

13.7 Each of the conditions of these terms of use operates separately. If any court or competent authority decides that any of them are unlawful or unenforceable, the remaining conditions will remain in full force and effect.

14. No right of withdrawal

14.1 You are aware of the fact that you have no right to withdrawal if you subscribe for the Tool or start to use the Tool.

15. Applicable law and disputes

15.1 Swedish law is applicable on these terms of use and any dispute shall be settled by a Swedish competent court.
